

# Power Award

## Objectives:

- The POWER Award will honor a WiNUP member who supports the goals of the organization locally and internationally.
- It will recognize an up-and-coming member's efforts and contributions to the organization.
- It will promote awareness of the contributions made to the industry.
- It will promote awareness of the nominee's contributions to other professional organizations.

## Eligibility:

Nominees must be active members for at least two years and no more than five years.

Details of activities should be on the official nomination form.

The previous year's recipient will serve as POWER Award Chair. She/he is responsible for all aspects of selecting the next recipient including:

- Request that Chapter Chairs submit nominations.
- Select a three-member committee to judge the nominees and tabulate the committee members' evaluation forms.
- Notify the Executive Director of the recipient's name. (Executive Director orders the award.)
- Present the award at the International Conference.

Members of the three-person judging committee will include members-at-large and members of chapters which do not have a POWER Award nominee.

Judges will take into consideration the nominee's involvement in WiNUP for a period of two to five years; leadership positions in the organizations both internationally and locally; leadership exhibited in other organizations and activities; and professional accomplishments. Nominees should describe how they have supported and continue to support EWRT/ WiNUP objectives.

Send the nomination form to the POWER Award Chair no later than June 15. (Each of the three judges will be sent a copy and a copy will be retained in the Executive Office.)

Nomination materials are limited to two pages: The nomination form and the nominee's statement.
